The tested model of Opel Corsa was introduced in Australia during 2012. This rating applies to all 3 door hatch variants with 1.4 litre engine. The 5 door hatch is unrated.

Dual front airbags, side airbags and head-protecting side curtains are standard equipment. Antilock brakes (ABS), electronic brake distribution (EBD) and electronic stability control (ESC) are also standard. An intelligent seat belt reminder is fitted to the driver seat. Dual pretensioners are fitted to the front seat belts to reduce slack in the event of a crash.

Head / neck: 3.00 points
Chest: 3.72 points
Upper legs: 4.00 points
Lower legs: 4.00 points

The passenger compartment held its shape well in the frontal offset test. There was a slight risk of serious head and chest injury for the driver. All passenger injury values were good. The clutch pedal moved rearwards by 16mm and downwards 21mm. All doors remained closed during the crash.

The airbag cushioned the head of the driver but it bottomed out and so a score deduction was applied. The passenger's head was cushioned by the airbag. There were no knee hazards.

Side Impact Test.

Each body region is scored out of 4 points

Head: 4.00 points
Chest: 4.00 points
Abdomen: 4.00 points
Pelvis: 4.00 points

Pole Test.

Scored out of 2 points

Vehicles are eligible for a pole test if fitted with head-protecting side airbags. The Opel Corsa was eligible and earned the maximum two points in this test.


