The tested model of Toyota Landcruiser 70 single cab chassis was introduced in Australia and New Zealand in October 2016. This ANCAP safety rating applies to single cab chassis variants built from September 2016. Other variants are unrated.

Dual frontal, side head airbags (curtains) and a driver knee airbag are standard. Advanced seat belt reminders are fitted to both front seats. Advanced safety assist technology features such as autonomous emergency braking (AEB) and lane support systems (LSS) are not available. ### Occupant Protection.

#### Frontal Offset Test

Each body region is scored out of 4 points

Head / neck:	4.00 points
Chest:	3.11 points
Upper legs:	4.00 points
Lower legs:	3.64 points

The passenger compartment held its shape well in the frontal offset test. Pedal and steering wheel displacements were well controlled. Driver and passenger contact with the airbags was stable. All doors remained closed during the crash.

#### Side Impact Test

Each body region is scored out of 4 points

Head:	4.00 points
Chest:	4.00 points
Abdomen:	4.00 points
Pelvis:	4.00 points

The side impact test normally used by ANCAP simulates a small car striking the driver's door of the test vehicle. Experience shows that large vehicles like this model can be expected to perform well in this test. ANCAP has adopted a policy of awarding these types of vehicles a default score of 16 points (out of 16).

This vehicle scored 12.17 out of 36 points (Marginal). Due to the design of this vehicle, zero points were awarded to regions likely to be struck by pedestrians legs. The central bonnet area offered mixed results for protection to head impacts, while the bonnet outer areas showed poor protection. (v8.2)
